The Declaration of Condominium of JETTY VILLAS, a Condominium, is recorded in O.R. Book 1002, page 1661, et seq., of the Public Records of Sarasota County, Florida. The following amendments to the Articles of Incorporation were then submitted to the entire membership of the Association at its meeting called and held on the 26th day of April, 1990, and approved by affirmative vote in excess of seventy-five percent (75%) of the entire membership of the Association as required by the Articles of Incorporation.

1. Article 2.1, Purpose, is hereby amended to read as follows:

2.1) Purpose. The purpose for which the Association is organized is to provide an entity pursuant to Section Chapter 718, Florida Statutes, Condominium Act, Florida Statutes, 1969, for the operation of JETTY VILLAS, a Condominium, located at ~~1555~~ 1585 Tarpon Center Road, Venice, Florida.


