The Declaration of Condominium of JETTY VILLAS, a Condominium is recorded in O.R. Book 1002, page 1665, et seq., as amended, of the Public Records of Sarasota County, Florida. The following amendment to the Articles of Incorporation was submitted to the entire membership of the Association at its meeting called and held on the 28th day of August, 1997, and approved by affirmative vote of 51% of the entire membership of the Association as required by the Articles of Incorporation.

Article 2.1, Purpose, is hereby amended to read as follows:

2.1) Purpose. The purpose for which the Association is organized is to provide an entity pursuant to Section 711.112 of the Condominium Act, Florida Statutes, 1969, now known as Chapter 718, F.S., for the operation of JETTY VILLAS, a Condominium, located at 1585 Tarpon Center Drive Road, Venice, Florida.
