JETTY VILLAS ASSOCIATION, INC., its address being 1585 Tarpon Center Drive, Venice, Florida 34285, Sarasota County, Florida, by the hands of the undersigned hereby certify that:

The Declaration of Condominium of JETTY VILLAS a Condominium, is recorded in O.R. Book 1002, page 1661, et seq., of the Public Records of Sarasota County, Florida. The following amendments to the Bylaws were then submitted to the entire membership of the Association at its meeting called and held on the 26th day of April, 1990, and approved by affirmative vote in excess of seventy-five percent (75%) of the entire membership of the Association as required by the Bylaws.

1. Article 1.1, Identity, is hereby amended to read as follows:

> .1 The office of the Association shall be at 1555 1585 Tarpon Center Road, Venice, Florida.

Article 2.2, Identity, is hereby amended to read as 2.

## follows:

.2 The fiscal year of the Association shall be the calendar year May 1 through April 30.

3. Article 6.2, Fiscal Management, Budget, is hereby amended to read as follows:

> .2 The Board of Directors shall Budget. adopt a budget for each <del>calendar</del> fiscal year that shall include the estimated funds required to defray the common expense and to provide and maintain funds for the foregoing reserves according to good accounting practices.

4. Article 6.3, Fiscal Management, Assessments,

is hereby amended to read as follows:

.3 Assessments. Assessments against the unit owners for their shares of the items of the budget shall be made for the calendar fiscal year annually in advance on or before December  $2\theta$  thirty (30) days preceding the fiscal year for which the assessments are made. Such assessments shall be due in 12 four (4) equal monthly guarterly installments, one of which

shall come due on the first day of each month calendar guarter starting with July 1 of the year for which the assessments are made. If an annual assessment is not made as required, an assessment shall be presumed to have been made in the amount of the last prior assessment and monthly guarterly installments on such assessment shall be due upon each installment payment date until changed by an amended assessment. In the event the annual assessment proves to be insufficient, the budget and assessments may be amended at any time by the Board of Directors if the accounts of the amended budget do not exceed the limitations for that year. Any account that does not exceed such limitation shall be subject to the approval of the membership of the Association, as previously required in these Bylaws. The unpaid assessment for the remaining portion of the <del>calendar</del> fiscal year for which the amended assessment is made shall be due upon the first day of the month guarter next succeeding the month in which the amended assessment is made or as otherwise provided by the The first assessment Board of Directors. shall be determined by the Board of Directors of the Association.

5. Article 6.7, Fiscal Management, Audit, is hereby

amended to read as follows:

.7 An <u>audit</u> of the accounts of the Association shall be <u>voted on at the annual members'</u> <u>meeting specifying the type of audit and if</u> <u>passed by a majority vote</u>, shall be made annually by a certified public accountant, and a copy of the audit report shall be furnished to each member not later than April 1 of the year following the year for which the audit is made 120 days from the end of the Association's fiscal year. If an audit of any type is NOT passed at any annual members' meeting, then the Board of Directors will furnish each member with essentially the same information within the same 120 day period.


