The term "institutional first mortgagees" as used in this Declaration shall mean all savings and loan associations, banks, and insurance companies holding first mortgages upon any of the Condominium Units. Notwith-standing any of the foregoing provisions of this Declaration, the written consent of all institutional first mortgagees shall be first obtained prior to (1) the subdivision of any Unit; (2) any change in the percentage of ownership of the common surplus; (3) any change in the percentage of participation in the common expense or assessments; (4) any change in the voting rights; (5) any change in the insurance provisions; (6) any amendments to this Declaration, for which the Federal National Mortgage Association or the Federal Home Loan Mortgage Corporation requires the consent of a specified number or percentage of holders of first institutional mortgagees Exhibits attached, the Articles of Incorporation or Bylaws (except merely formal amend-ments to the Declaration for the purpose of locating the proposed Units as constructed); and (7) termination of the Condominium. failure of the Association and Board of Directors to comply with and fully perform the terms of the Condominium documents and the

Condominium Act may constitute an actionable default under the terms of any institutional first mortgage, at the election of such institutional first mortgagee.


